NONDISCRIMINATION POLICY (catalog inside front cover)

~~It is the policy of Fresno Pacific University not to discriminate on the basis of race, color, nationality, handicap or sex in its admission policies, educational programs or employment policies, in compliance with all applicable federal regulations. This university is authorized under federal law to enroll nonimmigrant alien students.~~

In compliance with Titles VI and VII of the Civil Rights Act of 1964, Title IX of the Educational Amendments of 1972, and Section 504 of the Rehabilitation Act of 1973, Fresno Pacific University does not discriminate on the basis of race, color, national origin, gender, age, disability, or status as a veteran in the recruitment or admission of students or in any of its policies, practices, or procedures.

GRADE POINT AVERAGE (catalog page 56)

Addendum note: The cocurricular reporting policy (indicated by strikeout) was revoked on September 17, 2010. The policy was never implemented.

[Unchanged Policy:] A student's grade point average is obtained by dividing the total number of quality points earned by the total number of units undertaken, excluding courses in which the grades CR, I, IP, NC, NR, W and AU were received. Transfer units are not counted in calculating the GPA on the Fresno Pacific University transcript. Only FPU credits counted toward a degree are used in calculating the cumulative GPA.

~~*[Revoked Policy:]* For cocurricular reporting purposes in which GPA is a requirement for participation for transfer students, the total cumulative GPA from all institutions attended will be used at the completion of the first semester of attendance at FPU (not including summer). Upon completion of the second semester of attendance at FPU and thereafter, the FPU only cumulative GPA will be used for cocurricular activity reporting purposes.~~

GRADE APPEALS PROCESS (catalog page 57 and 69)

Addendum note: Student grade appeals should now be submitted to the Registrar's Office by using the Academic Petition form. The Registrar's Office will coordinate the process with the designated officials.

GENERAL EDUCATION SUMMARY: DEGREE COMPLETION (catalog page 86)

Addendum note: The total units required in Subject Area #1 should be 9 semester units or 12-15 quarter units instead of 6 semester units or 8-10 quarter units.
